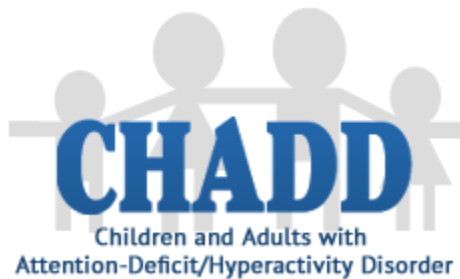


Policy on Childcare Provided at CHADD Meetings

- CHADD does not encourage our local affiliates to provide childcare in conjunction with CHADD events, because of the high level of risk involved for the children and for CHADD.
- We recognize that many parents may not be able to attend local events unless childcare is provided.
- In those cases where a local affiliate decides to provide child care, the following conditions must be met:
 1. An adult (over age 21) must remain with the children at all times.
 2. The parents must remain within the building where the childcare is offered.
 3. Each parent must sign a copy of the [CHADD RELEASE AND CONSENT AGREEMENT](#) and coordinators will maintain copies in their files.

Childcare Release and Consent Agreement

I have agreed to my child or children's participation in volunteer-provided daycare arranged by Children & Adults with ADHD (herein, "CHADD").

I AM VOLUNTARILY USING THESE DAYCARE SERVICES PROVIDED BY CHADD FOR THE DURATION OF CHADD MEETINGS IN WHICH I AM A PARTICIPANT WITH FULL KNOWLEDGE, APPRECIATION AND UNDERSTANDING OF THE POTENTIAL DANGERS AND RISKS INVOLVED.

I HEREBY AGREE TO ACCEPT ANY AND ALL RISKS ATTRIBUTABLE TO THE ATTENDANCE OF MY CHILD OR CHILDREN AT CHADD MEETINGS AND CHADD-PROVIDED DAYCARE INCLUDING BUT NOT LIMITED TO, ILLNESS, SERIOUS PERSONAL INJURY, DEATH AND/OR PROPERTY LOSS. I UNDERSTAND THAT I AM RESPONSIBLE FOR MY CHILD OR CHILDREN'S OWN HEALTH CARE AND HEALTH INSURANCE.

I hereby release, hold harmless and indemnify CHADD, and their constituents, members, representatives, agents, volunteers, and assigns (the "Releasees") from and against any and all claims and causes of action which I, my child or children, or a third party may have now, or which I, my child or children, a third party, or any of my heirs, executors, administrators, personal representatives, assigns or successors may have at any time in the future, including, without limitation, claims and causes of action for injury, death, property damage or destruction, or any other claim or cause of action arising out of or related to the attendance of my child or children at volunteer daycare provided by CHADD, including but not limited to any such claims or causes of action resulting from or arising out of the negligence of any of the Releasees.

No person on behalf of CHADD has made any representation or promise, express or implied, in connection with this agreement or the subject matter hereof which is not contained herein.
