## **Chapter Annual Report Request**

- Coordinators are encouraged to prepare a small Annual Progress Report to be submitted to the national office by JULY 31st each year and include the following information:
  - a. number of board meetings held in the past year
  - b. summary of board minutes
  - c. number of chapter and branch meetings and average attendance
  - d. checking account balance as of June 30<sup>th</sup>
  - e. inventory of chapter and branch assets as of June 30th
  - f. summary of past year strengths and weaknesses
  - g. goals for the coming year
  - h. officers (with contact info) and other Advisory Board members for the new year
  - i. How national could provide greater support for your chapter
- This isn't mandatory, but we are recommending this so that we know what's happening at your local Chapter and what we can do to help you in your efforts.
